1. Opening Remark by the Chair, Introduction and Safety Moment

Eric Hopkins, Chair of OCUC, started the meeting at 8:46AM and asked everyone to introduce themselves one by one. He followed with the safety moment citing a video he saw yesterday where a whole family were saved by a vehicle on green collided with another one which was running a red light. He used it to illustrate the risk we take every day at work. A risk does not happen today does not mean it will not happen the next day. We shouldn't have to think of taking a risk to cross the road; but in reality, things happen. We are all in the safety business. When we see something was done in an unsafe manner and although nothing has happened at the time, we still should reflect on it and remind ourselves that it should not have done in such an unsafe manner.

2. Approval of Agenda

The agenda, as presented, be approved and the Chair be authorized to suspend the regular order of business.

3. Approval of Council Minutes September 13, 2019

Minutes were sent to all members by emails earlier and no comment was received.

4. Subcommittee Report

4.1 Education –

Eric H mentioned that in the board meeting last night that he mentioned Durum District School Board sent out a request for donation for safety boots for under privilege people who joint the construction industry. The Board approved to send \$500 to the cost and recommended that it be brought forward to the council for endorsement. The council approved the recommendation of the Board. Doug R mentioned that the Skill Trade Expo will be held November 8 from 9 am to 2 pm and asked members to attend if possible. The Expo will show the virtual reality head set that we saw in the September meeting presented by EXO/ES Fox. That will educate the public more above construction trades than just the masonry, electrician and bumbling.

4.2 Health and Safety

Michael N, H & S subcommittee chair announced that the new Health & Safety Provincial Coordinator, Pierre Rouleau, is in the meeting and invited him to speak and give update of MOL activities. Pierre R said that the old MTCU is now the wing of MOL as MOL Training, Skill and Development. He did not intend to give any update at the moment but would like to find out during breaking talking with OCUC members what it want him to bring to the table in the future. He would answer any question OCUC members might have; and if he cannot at that moment he would bring those questions to the appropriate committees that he sits on and would provide answers and feedbacks later. With the new portfolios added to it, it would remain to be seen how the organization would move forward.

Michael N mentioned that he attended a COR meeting recently and was told that there will be changing to the COR, may be calling as COR 2020, with added four elements to the program such as contractor safety management, safety procurement, documents control and record keeping. Michael N also mentioned that WSIB is also introducing a new Health and Safety Excellence Program. This program has three levels: the basic, intermediate, and advance. There would be some incentive for the employers who participated in it. Once attended the advance level, the employer can merge into the new COR program and thus accredited by MOL. However, Ian C said one does not need COR to be accredited. The other program which is accredited by MOL is ISO 4501 which must be equivalent to COR. As for the construction industry, there are two things as Eric H said that matter. One is the ultimate goal is work safety and other is to win work. As an owner, if owner sees value on COR, not just paper chase, owner will support that. But if owner does not see change in the contractor's safety data, then the owner will question the COR value. Also does it mean to owner the potential of rate reduction; therefore, does it make a business being more competitive, or business making more money. OCUC will want to bring all parties together for next council meeting in December to discuss this subject.

Ian Cunningham provided the update information on the 2019 MOL October report to PLMHSC - MOL REPORT TO LABOUR-MANAGEMENT NETWORK –

Section 1: For August 1 – August 31, 2019: Fatality – 2; Critical Injury – 22 totalling 24. As compared to the same period last year of 1 and 33 totalling 34 respectively.

Section 2: Recent new in Ministry of Labour: Protecting vulnerable workers Sign up for workplace safety consultations Changes Made to Dive Notice Submission Musculoskeletal disorders and respiratory hazards blitz

Section 3:

Court Bulletin 1 – Worker's Fatal Fall Results in \$400,000 Fine for Mississauga Company with Record of Convictions - While giving a tour of the facility to demolition contractors, a worker fell nearly 30 feet to the ground from a walkway that had corroded and could not support the worker's weight. The worker later died in hospital.

Section 4: Critical Injury for the period from January 1 to August 31, 2019 was 192.

Section 5: Fatal Injuries for the period from January 1 to August 31, 2019 was 7 (3 due to fall).

5. Presentation I: The New Construction Act Ted Dreyer, Madorin Snyder LLP

Ted acts for Owners, Contractors, and Subcontractor in disputes in the industrial, commercial and institutional construction sector. Ted was recently appointed as an adjudicator pursuant to the new Construction Act.
